All students of UG Batch 2022 desirous of seeking admission to 7th and 8th Semester for 4th Year Honors / 4th Year Honors with Research in other colleges are hereby informed that the list of colleges/program-wise vacancies are available on the Directorate Colleges Portal <https://directorcollegesjk.in/VacanciesFourthYear.aspx> . The vacancy list is as per the information being submitted by the colleges in realtime, and as such will be regularly updated. 1. Students are advised to visit the websites of respective colleges for further information.
2. Students must fulfil the eligibility criteria for admission to the 4th year as laid down by the affiliating university of the college they wish to seek admission.
3. Admissions are provisional and will be confirmed only when the minimum enrolment of a subject is reached, failing which the students will be required to shift to other colleges.
4. In case the Minor field of study of a student is not offered by the college to which they are migrating, the colleges can: (a) Collaborate with a neighbouring college for offering the minor, or (b) offer blended/hybrid delivery using prescribed MOOCs or University-approved online modules in consultation with the Board of Studies.
5. All other terms and conditions notified earlier vide No: DC-HE/2025/ 1152 dated 15-06-2025 shall remain unchanged.
